**Other Fees:**

- Re-enrollment Fee: \$115 DUE in January from current families.
- Application Fee: \$175 DUE at time of application.
- Development Fee: \$400 DUE UPON ACCEPTANCE (New families to MCCS)

**Withdrawal Fee:**

It is assumed you are enrolling your student for the entire year; therefore, budgets and salaries are set accordingly. If, after enrollment, a student(s) is voluntarily withdrawn; a 30-day written notice is required. At that time, a fee of \$950.00 for grades K4 five-day through 8th and a fee of \$500.00 for 3 year old PreSchool through K4 three-day will be due and payable per student in addition to the current month's tuition payment. If a student(s) is suspended or dismissed, at that time a fee of \$950.00 for grades K4 five-day through 8th and a fee of \$500.00 for 3 year old PreSchool through K4 three-day will be due and payable per student in addition to the current month's tuition payment. The business office will handle these issues on an individual basis.

## Financial Information, Policies and Terms

### New Family Information

- \* **UPON ACCEPTANCE OF NEW STUDENTS (including siblings) an amount equal to 1 month of that student's tuition (based on 12-pay) will be due.**
- \* NEW FAMILIES will also owe the Development Fee of \$400.00 at the time they are accepted.
- \* Regardless of whether the tuition plan chosen is 1 payment or 12 payments, the deposit will be based on the 12 payment plan and will be subtracted from the tuition due on **June 15th** or the month after acceptance.

### Middle School Retreat

The middle school retreat ***is included*** for all sixth ~ eighth graders.

### Tuition Payment, Policies and Rate

- \* All three year old's that enter our preschool program are required to be completely potty trained without the assistance of diapers or pull-ups.
- \* Any child having 3 potty related accidents in a quarter will be dismissed from the program.
- \* Tuition is due the 15th of each month, June through May.
- \* All full tuition payments are due by **JUNE 15**.
- \* Any full tuition payment not received by **July 1** will be put on a payment plan and payments will be calculated based on the payment plan tuition amount divided over the remaining months in the school year.
- \* The first months tuition is due on **June 15** and will be considered late on **June 16th**. If the first months tuition is not received by **July 1**, then the student (s) will no longer be considered enrolled at MCCS.
- \* All Payments are due on the 15th of the month. Any payment received after the 15th is considered late and will be assessed a delinquent fee of 50.00 every month that the invoice(s) are past due
- \* No tuition account will be allowed to be more than 2 months past due and remain enrolled at MCCS.
- \* At the time a tuition account becomes 2 months past due, a notice will be sent to the family giving them seven days from the date of the notice to make the account current, including late fees.  
Example: Tuition for September is due on September 15. The account will be two months past due on November 14. The family will have until November 21 (unless the 7th day is on a weekend or holiday, then the 1st business day) to pay the current amount due in order to stay enrolled.
- \* Returned checks will result in a \$30.00 charge.
- \* If two checks are returned as insufficient in the same school year, personal checks will no longer be accepted as payment for anything.
- \* **NO sibling discount is given for students in 3 Year old Preschool - K4 5day.**  
Example: One student in a full day program and one student in the half day program, both will be full tuition cost, neither receives a sibling discount.
- \* Students who have delinquent accounts will have a hold placed on their records. Report cards and test results will not be released until the account has been paid in full.

### Re-enrollment Fee

This non-refundable, non-transferable fee applies to all returning students. It verifies that your student will be returning next year provided they end the year in good standing.

### Application Fee

This non-refundable, non-transferable processing fee is assessed to all new students enrolling in MCCS. It also applies to the siblings (who were not enrolled the previous year) of returning students. The fee is due before a student is considered for enrollment.

### Development Fee

This non-refundable, non-transferable fee is a one time capital growth and enhancement fee assessed to all **new families** to MCCS. This fee is due at acceptance.
